Therefore, clients release FACEFORWARD and its representatives and subsidiaries of all claims of injury, seen or unseen that may occur as a result of any makeup service including but not limited to makeup application. Client signing will be the responsible party for the total fee of the service package (Both self & party, if individuals listed as payees are unable to tender funds on the day of the event.) All the rates are based on the information stated in this contract (date of event, number of parties, traveling location, time of event, makeup style). If you must change any information already stated above or spoken, we recommend you consult with FACEFORWARD Artist at least 72 hours prior to your event.
